### Purposes and legal bases of data processing

With regard to video surveillance / image recording, we process your data on the basis of Art. 6 para. 1 lit. f GDPR and §4 Abs. 1 No. 2 and 3 BDSG, which means to uphold our householder's rights and to protect the legitimate interests of us or third parties. These legitimate interests are, in particular, the protection of our company and our employees and the protection of our property.

### Transfer of tasks to other bodies (companies or individuals) / recipients and recipient categories of personal data

#### External service providers

We perform certain tasks, such as the installation, the configuration and the maintenance of the video surveillance system, where the access to personal data can not be excluded, not by ourself, but transfer the handling to a service company. We maintain an up-to-date list of the bodies and categories of bodies that, as agreed, process personal data for us, indicating the tasks assigned. ### Additional recipients

In the event of an incident, we may submit your personal information to other recipients. These are usually the competent law enforcement agencies.

### **Duration of data storage**

The storage period is 7 days. Thereafter, your personal data will be automatically deleted, if it is no longer required for the fulfillment of the above named purposes. Personal data will only be stored longer if necessary to clarify an incident. The retention period in these cases is governed by the law (for example, obligation to produce proof and to preserve records) and can be up to ten years.

### **Rights of data subjects**

The rights of the data subject in relation to the processing of their personal data are regulated in Articles 15 to 22 GDPR.

### Right to information, right to rectification, cancellation or restriction

Under the above named address you can request information about the data stored about your person. In addition, under certain circumstances, you may request the correction or deletion of your data. You may also be entitled to a restriction on the processing of your personal data and a right to return the data you provide in a structured, common and machine-readable format.

#### **Right of objection**

**If we process your data in order to safeguard legitimate interests, you may object to this processing if your particular situation gives rise to reasons that speak against the processing of data.**

### Right of complaint

You have the option of complaining to the DEVK Data Protection Officer or to a data protection supervisory authority. The data protection supervisory authority responsible for us is:
