

Information sheet Data Protection for business partners of DEVK-RE

With these instructions, we inform you about the processing of your personal data and your rights under the data protection law.

Purposes and legal basis of data processing

We process your personal data in compliance with the General Data Protection Regulation (GDPR), the Federal Data Protection Act (BDSG), the data protection law relevant provisions of the Insurance Contract Act (VVG) and all other relevant laws.

We process your data in order to safeguard our legitimate interests or those of third parties (Art. 6 Para. 1 lit. f) GDPR), in particular for the proper and customary maintenance of customer relationships. For this purpose, we process your first and last name, your title, your position in the company and your business contact details (email address, telephone number, address).

In addition, we process your private contact details (e-mail address, telephone number, address) and, if necessary, additional information that guarantees good customer service (e.g. your preferences for accommodation or meals), provided you have given us your consent in this regard (Art. 6 Para. 1 lit. a) GDPR). You can revoke this consent at any time. The processing of your personal data remains lawful until you withdraw your consent.

If we want to process your personal data for a purpose not mentioned above, we will inform you beforehand within the framework of the legal provisions.

Duration of data storage

We store the personal data named above for the duration of our business relationship. They will be deleted no later than the end of the second year in which we had no contact with you.

Rights of data subjects

Pursuant to Articles 15 to 22 GDPR, you have certain rights to the processing of your data.

Right of Access, Right to rectification, erasure or restriction

Under the named above address you can request access to the data stored about your person (Art. 15). You also have the right to disclose the information you provide in a structured, common and machine-readable format (Art. 20).

In addition, subject to certain conditions, you may request the rectification, erasure or restriction of the processing of your personal data (Articles 16 to 18).

Right to object and revocation of consent

You have the right to informally object to the processing of your personal data for direct marketing purposes at any time (Art. 21 Paragraph 2).

If we process your data to safeguard legitimate interests, you can object to this processing if your particular situation gives rise to reasons that speak against data processing (Art. 21 Paragraph 1). You can revoke your consent in accordance with Article 6 (1) (a) GDPR at any time with effect for the future. The processing of your personal data remains lawful until you object or withdraw your consent.

Right of complaint

You have the option of complaining to the DEVK Data Protection Officer or to a data protection supervisory authority. The data protection supervisory authority responsible for us is:
